**Acquisti, Alessandro** is an Associate Professor of Information Technology and Public Policy at the Heinz College, Carnegie Mellon University, a member of Carnegie Mellon Cylab, and a fellow of the Ponemon Institute. His work investigates the economic and social impact of IT, and in particular the economics and behavioral economics of privacy and information security, as well as privacy in online social networks. He has received national and international awards, including the PET Award for Outstanding Research in Privacy Enhancing Technologies and the IBM Best Academic Privacy Faculty Award.

**Bamford, James** is an author and journalist, and one of the leading experts on the US intelligence agencies. His 1982 best seller "The Puzzle Palace" was the first book to describe the inner workings of the National Security Agency. His subsequent books "Body of Secrets" (2001), "A Pretext for War" (2004), and "The Shadow Factory: The NSA from 9/11 to the Eavesdropping on America" (2009) have received widespread acclaim. Throughout his career, Mr. Bamford has made effective use of the Freedom of Information Act. He was formerly Washington Investigative Producer for ABC's World News Tonight.

**Bayer, Mark** is Deputy Chief and Legislative Director for Representative Ed Markey (D-MA). During his 12 years on Capitol Hill, he has worked with Rep. Markey, who serves as Co-Chairman of the Bi-Partisan Privacy Caucus, on a variety of privacy measures, including medical privacy, data breach, and online privacy. Most recently, Mark worked with Rep. Markey on the health IT privacy and security provisions that were enacted as part of the Recovery and Reinvestment Act. Mark is a graduate of Harvard University's Kennedy School of Government and Cornell University.

**Bruggeman, David** is the public policy analyst for the Association for Computing Machinery, where he conducts research and analysis on a broad range of issues involving computing and technology policy. Before joining ACM, David worked on several reports for the National Academies as part of its Policy and Global Affairs Division. He also worked at the National Oceanic and Atmospheric Administration as an International and Interagency Affairs Specialist. David has a bachelor's degree in Politics from Whitman College, a master's degree in science, technology and public policy from George Washington University, and has completed Ph.D. coursework in Science and Technology Studies at Virginia Tech.

**Calabrese, Chris** is ACLU Legislative Counsel for privacy-related issues for its Washington Legislative Office. Prior to joining the Washington Legislative Office, he served as Project Counsel to the ACLU Technology & Liberty Project, which monitors the interplay between cutting-edge technology and civil liberties. He works with members of Congress, their staff and federal agencies to keep Americans' privacy safe

from threats posed by the ever-expanding collection of personal information by the government and private sector.

**Callahan, Mary Ellen** is Chief Privacy Officer of the U.S. Department of Homeland Security. Prior to joining the Department, Ms. Callahan specialized in privacy, data security, and consumer protection law as a partner at Hogan & Hartson, LLP, where she worked for more than ten years. She was the Co-Chair of Online Privacy Alliance, a self-regulatory group of corporations and associations established to create an environment of trust and foster the protection of individuals' privacy online. Ms. Callahan also served as Vice-Chair of the American Bar Association's Privacy and Information Security Committee of the Antitrust Division.

**Cantor, Jonathan R.** (CIPP, CIPP/G), joined the Social Security Administration in 1998. Before SSA, Mr. Cantor received his J.D. with honors from George Washington University, and his A.B. cum laude from Duke University. After law school, he joined SSA as an attorney and focused on the Freedom of Information Act, the Privacy Act, and data exchange. In October 2003, he became the Deputy Executive Director, Office of Public Disclosure (now Office of Privacy and Disclosure) and SSA Privacy Officer. In 2005, he became the Executive Director for Privacy and Disclosure. He speaks frequently on privacy policy, practices, and open government.

**Coney, Lillie** is Associate Director with the Electronic Privacy Information Center (EPIC) in Washington, DC. Ms. Coney joined EPIC in 2004 to head up the organization's voting and privacy project, and in 2005, she became Associate Director. Her work encompasses original research and writing on topics that influence privacy rights and civic participation. In 2009, House Speaker Nancy Pelosi appointed her to the Election Assistance Commission (EAC) Board of Advisors. EAC is an independent, bipartisan commission charged with developing guidance to meet Help America Vote Act requirements, adopting voluntary voting system guidelines, and serving as a national clearinghouse of information about election administration. She also, directs the work of EPIC's Privacy Coalition project, which hosts meetings to engage policy makers, decision makers, and industry leaders on matters of interest to privacy, consumer, and civil liberties advocacy organizations.

**Cherry, Michael** is President of Cherry Biometrics Inc. <http://www.cherrybiometrics.com/> a firm that provides ID solutions and Cyber Security. He is Vice Chair of the Digital Technology Committee for the National Association of Criminal Defense Lawyers. His firm's expert witness record of success in challenging fingerprints is 87%.

**Dakin, Shaun** is the CEO and Founder of The National Political Do Not Contact Registry, a program by Citizens for Civil Discourse. Mr. Dakin launched StopPoliticalCalls.org and grew membership to over 85,000. During this time Mr. Dakin became the most recognized expert in the nation working on protecting voters from the scourge that is modern political campaigning: robo calls or automated political calls.

**De Mooy, Michelle** is Senior Associate, National Priorities, joined Consumer Action in January 2008 after 10 years of working on behalf of social justice issues. Prior to Consumer Action, she was the Director of Development and Communications at Fair Chance, a nonprofit that provides organizational development services to grassroots community groups serving children and families. Before that, Michelle was a Senior Consultant for eCampaigns at M+R Strategic Services, where she managed media strategy for the Campaign for Tobacco-Free Kids, The Wilderness Society, and labor rights group American Rights at Work. Before relocating to DC in 2005, Michelle provided strategic marketing, communications and technology consulting for non-profits and universities in the Philadelphia area, including the Women's Opportunities Resource Center, To Our Children's Future With Health, the University of Pennsylvania and Villanova University.

**Feldman, Emily** is with the American Association of Law Libraries. She assists with legislative advocacy and communications programs. She works with the Government Relations Committee by attending hearings, coordinating action alert campaigns, and promoting advocacy among association members.

**Fraser, Cynthia** is a Technology Safety Specialist for the Safety Net Project. Through training, technical assistance, and policy advocacy, she addresses how technology impacts survivors of stalking, domestic and sexual violence. She has 18 years experience working to end violence in the US and Canada at local hotline, shelter, court, and victim advocacy organizations as well as nationally at organizations such as the US Institute for Women's Policy Research. At the National Resource Center on Domestic Violence from 1997-2003, her work focused on creating the National Online Resource Center on Violence Against Women and building the capacity of anti-violence agencies to use technology effectively for violence prevention, intervention and education.

**Friedman, Phil Philip** Friedman is a leading consumer attorney in Washington, DC. His cases have established important precedent concerning the legal remedies available to consumers, and also provided significant financial support for law school clinics and consumer advocacy organizations throughout the Washington, DC area. Mr. Friedman is also a specialist in election law. Mr. Friedman is admitted to practice in the District of Columbia, Maryland and California. Mr. Friedman is also a member of the American Trial Lawyers Association, Trial Lawyers for Public Justice, and the National Association of Consumer Advocates.

of *The Privacy Rights Handbook: How to Take Control of Your Personal Information* (Avon, 1997) and is co-author of *Privacy Piracy: A Guide to Protecting Yourself from Identity Theft* (1999). She contributed a chapter on consumer and privacy rights to the 2006 book, *RFID: Applications, Security and Privacy*.

**Goins, Hope** serves as counsel for the United States House of Representatives Committee on Homeland Security, Majority Staff. Ms. Goins serves as the Primary advisor to Chairman Bennie G. Thompson, on issues involving privacy, civil rights, and civil liberties at the Department of Homeland Security (DHS). She also provides advice, guidance, and support on matters involving privacy, civil rights, and civil liberties at DHS to each of the six Subcommittees, which fall under the Committee's jurisdiction. Ms. Goins is a graduate of Tougaloo College and the University of Arkansas School of Law.

**Gordon, Dr. Nancy** has been a member of the Executive Staff at the U.S. Census Bureau since 1995 (Associate Director for Demographic Programs 1995–2005 and her current job). Before the Census Bureau, she was on the Executive Staff of the Congressional Budget Office for 15 years, leading the group working on Medicare, Medicaid, Social Security, health care reform, post-secondary education, housing, and economic development. She is a strong advocate for innovative programs and techniques. At the Census Bureau, she oversaw development of two major programs—the American Community Survey and Local Employment Dynamics, including OnTheMap.

**Gordon, Roger** is the former executive director of the Center for Legal Empowerment, Accountability & Reform (CLEAR), a national consumer organization that advocates for greater access to justice and accountability in the legal system. He received his MBA from Northwestern University and is about to receive his J.D. from Georgetown. While in law school, Roger clerked with the U.S. Attorney's Office for the District of Columbia (Narcotics & Organized Crime Group), the Center for American Progress, and the House Judiciary Committee (Committee on the Constitution, Civil Rights and Civil Liberties). He has served on the executive committee of Human Rights Watch's California Committee North and been an outspoken advocate on Second and Fourth Amendment issues, most recently serving on John Conyers' Braintrust Panel on Racial Profiling. Before coming to Washington, Roger led a community economic development organization in San Francisco that helped low-income entrepreneurs start businesses in challenging neighborhoods. He is a native of Brooklyn, New York.

**Grant, Sharon** is Senior Director of External Relations for Carnegie Mellon University's Carnegie Institute of Technology (CIT). Sharon is responsible for CIT's activities in Washington and is focused on advocating for CIT's federal and corporate priorities, further distinguishing CIT's reputation as a research resource, and developing CIT's contributions to sound public policy. Grant joined Carnegie Mellon in May of 2002 after serving eight years as a senior staff member for Congressman Mike Doyle (PA-14). As Legislative Director, Grant managed all legislative and appropriations operations and staff. Grant contributed to the development and implementation of extensive organizational and policy agendas and the coordination of federal support for projects

and services benefiting the western Pennsylvania region. During her tenure, Grant was responsible for a wide-ranging legislative portfolio including handling the member's Energy and Commerce Committee, Science Committee, and Veterans Affairs Committee activities.

**Grant, Susan** is Director of Consumer Protection at Consumer Federation of America, a nonprofit association of some 300 non-profit consumer groups that was established in 1968 to advance the consumer interest through research, education, and advocacy at both national and state levels. Ms. Grant works specifically in the areas of privacy, deceptive marketing, online safety and security, fraud, electronic and mobile commerce, and general consumer protection issues. Ms. Grant is also involved in global consumer protection issues through her work in the Trans Atlantic Consumer Dialogue, a group of consumer organizations in the United States and the European Union countries that provides input on cross-border consumer issues.

**Griggsby, Lydia** is the Chief Counsel for Privacy and Information Policy for the Senate Judiciary Committee. This unique position calls for Ms. Griggsby to provide legal and policy advice to Senate Judiciary Committee Chairman Patrick Leahy on a wide range of legal issues at the intersection of privacy, the Freedom of Information Act, freedom of the press and civil liberties. Ms. Griggsby negotiated the first major reforms to FOIA in more than a decade – the OPEN Government Act of 2007 – which former President Bush signed into law on December 31, 2007. Recently, she served as the lead Senate counsel on the OPEN FOIA Act reform bill, which President Obama signed into law on October 28, 2009. In addition to her work on FOIA, Ms. Griggsby provides legal advice to the Senate Judiciary Committee on a broad range of other issues, including freedom of the press, information privacy and security, and cyber security.

**Hendricks, Evan** author, investigative journalist and consumer privacy law expert. Since 1981, Evan Hendricks has been Editor/Publisher and founder of Privacy Times, a newsletter based in the Washington, D.C. area. Through the newsletter alone, he has published nearly 3,000 pages covering a wide range of privacy and information law subjects, including the Fair Credit Reporting Act, Privacy Act, Freedom of Information Act, Gramm-Leach Bliley, and the USA Patriot Act. Mr. Hendricks regularly testifies before Congress, with eight appearances between 2003-2006. He is a regular presenter at Federal Trade Commission workshops. The courts have qualified him as an expert witness in FCRA and identity theft cases. Mr. Hendricks has served as a consultant on privacy issues to Federal and State governmental organizations, and businesses. He has been a featured American presenter at events in Paris, France, Venice, Italy, Cardiff Wales, London, England and Ottawa, Ontario. Mr. Hendricks has a Bachelor of Arts from Columbia College, Columbia University. He attended there after transferring from University of Oregon.

**Jansen, J. Bradley** is the Executive Director of the Center for Financial Privacy and Human Rights was founded in 2005 to defend privacy, civil liberties and market economics. The Center was the first non-profit human rights and civil liberties organization whose core mission recognizes traditional economic rights as a necessary

foundation for a broad understanding of human rights. CFPHR is part of the Liberty and Privacy Network, a non-governmental advocacy and research 501(c)(3) organization.

**Joel, Alexander** is the Civil Liberties Protection Officer for the Office of the Director of National Intelligence (ODNI). His responsibilities include ensuring that the policies of Intelligence Community agencies include adequate protections for privacy and civil liberties, reviewing privacy and civil liberties complaints relating to ODNI programs, and ensuring that the use of technology sustains privacy protections. Mr. Joel's prior experience includes working as an attorney for the CIA, serving as the privacy and e-commerce attorney for Marriott International, working as a technology attorney for a major D.C. law firm, and serving in the U.S. Army JAG Corps. He received his law degree from the University of Michigan and his B.A. degree from Princeton University.

**Kaplan, Sheila** is a longtime education researcher, publisher, consultant, program developer, and former school board member. She founded and developed 'Kids in Downtown Spaces' (KIDS), a multicultural museum without wall in Tucson, AZ in the mid-1980s before returning to New York. She works to promote public access to information. In the 1990s she founded Education New York -- the only independent education print publication in New York state. Education New York Online was the next generation of her efforts to offer education news, policy and research, and related information to as wide an audience as possible. She founded Information Policy Watch in June, 2008 to a Web resource on FERPA and privacy policies.

**Levin, Blair** currently is the Executive Director of the Omnibus Broadband Initiative at the Federal Communications Commission. In his current role, he oversees the development of a National Broadband Plan, a project mandated by Congress in the America Recovery and Reinvestment Act. Mr. Levin rejoined the Commission in June after eight years as an analyst at Legg Mason and Stifel Nicolaus. As Barron's Magazine noted, Levin "has always been on top of developing trends and policy shifts in media and telecommunications ... and has proved visionary in getting out in front of many of today's headline making events."

**Libin, Nancy** Chief Privacy and Civil Liberties Officer with the Department of Justice. The Chief Privacy and Civil Liberties Officer (CPCLO) is the Department's senior policy advisor on privacy and civil liberties issues related to counterterrorism and is responsible for advising the Attorney General on issues of privacy policy related to the Department's compliance with privacy laws and regulations. The CPCLO periodically reviews and investigates the Department's activities to ensure the Department is adequately considering privacy and civil liberties. In carrying out these responsibilities, the CPCLO works collaboratively with Department components and Bureaus, such as the Office of Legislative Affairs, the Office of Legal Policy, the Criminal Division, the National Security Division and the FBI.

**Mackinnon, Rebecca** is a 2009 Open Society Institute fellow, working on a book about China and the global Internet. She is cofounder of Global Voices, a global citizen media network. In February 2010, she will begin a fellowship at Princeton's Center for

Information Technology Policy. Fluent in Mandarin Chinese, she was previously CNN bureau chief in Beijing and in Tokyo. She is a founding member of the Global Network Initiative, an initiative to advance freedom of expression and privacy in the Internet and telecoms sectors. She was also public lead in 2007 and 2008 for Creative Commons Hong Kong. She has previously been a fellow at the Shorenstein Center on the Press, Politics and Public Policy at Harvard's Kennedy School of Government, where she focused on blogs and participatory online media in international news, and at the Berkman Center for Internet and Society.

**McCall, Ginger** is Staff Counsel at EPIC, where she works on EPIC's litigation matters, including amicus curiae briefs, open records requests, and national security matters. Ms. McCall is a graduate of Cornell Law School and graduated magna cum laude from the University of Pittsburgh with a B.A. in English Literature. While in law school, she was the head of the Cornell Law School National Lawyers Guild, helped to found the Cornell Law School National Security Law Society, was ranked as a semifinalist in Cornell Law School's Winter Cup moot court competition, and was a Cornell Judicial Codes Counselor (representing students before Cornell's academic and conduct hearing boards). Ms. McCall spent her first law school summer interning with the American Civil Liberties Union in Pittsburgh, PA and her second summer as a clerk with EPIC. While clerking with EPIC, Ms. McCall worked on projects involving a variety of privacy topics, including spyware protections, medical record privacy, and the Freedom of Information Act. Because of her work in civil rights, Ms. McCall was awarded the Freeman Prize for Civil and Human Rights by Cornell Law School.

**Molina, Pablo** has been the chief information officer at the Georgetown University Law Center Campus since October 2000. Prior to that, he held similar positions at the University of Pennsylvania and Washington University in Saint Louis, and was a lecturer at the University of Missouri - St. Louis. Before his career in academia, Mr. Molina founded and managed a technology company in Spain, where he also served as editor-in-chief of computer magazines, authored several books on technology, and taught information technology at the Escuela de Hacienda Pública in Madrid. Mr. Molina has Bachelor's and Master's degrees from Saint Louis University, has done graduate coursework at the University of Pennsylvania and Washington University in St. Louis, and currently is pursuing a Doctorate in Liberal Studies degree at Georgetown University. He is a Microsoft Certified Systems Engineer, a Certified Novell Engineer, and a Certified Information Systems Security Professional.

**Peel, Deborah** is the founder of Patient Privacy Rights, based in Austin, Texas, and one of the leading advocates for medical privacy in the United States. A practicing psychiatrist for 27 years, she understands that people will avoid or refuse necessary medical treatment if they think others can see or use their private and personal medical records. She has provided testimony to Congressional committees on genetic privacy and medical record privacy. She recently led a coalition of 26 organizations across the political spectrum that urged Congress to insure that patients control access to their medical records in all electronic health systems.

**Perrin, Stephanie** is the Director of Integrity Policy at Service Canada, the largest service delivery department in the Canadian federal government. She was the former Director of Research and Policy at the Office of Privacy Commissioner, Canada. She was a well-known consultant in privacy and information policy issues, providing advice to industry and government in the practical implementation of data protection policies and procedures, and an active participant in policy discussions involving civil liberties. She is the former Chief Privacy Officer of Zero-Knowledge, the first CPO in Canada, and has been active in a number of CPO associations, working with those responsible for implementing privacy in their organizations. Active in domestic and international privacy policy and compliance fora, Stephanie has been involved in privacy issues at the practical, policy and legislative level for many years.

**Pierce, Deborah** is the Executive Director of PrivacyActivism. Her work focuses on consumer education campaigns, advocacy, and analysis of privacy issues, with particular emphasis on privacy and social networks. Early this summer PrivacyActivism will be releasing online, and in print, a graphic novel detailing the adventures of Carabella as she negotiates college life, social networks, privacy, and space aliens. The comic is aimed at high school students. In 2005, Deborah chaired the Association for Computing Machinery's Computers, Freedom, and Privacy (CFP) conference, bringing together attendees not only from government, business, education, and non-profits, but also from the community of computer professionals, hackers, crackers and engineers who work the code of cyberspace.

**Pietra, Peter** is the Transportation Security Administration's Director of Privacy Policy & Compliance with responsibility for privacy matters affecting the traveling public, transportation sector workers, and more than 50,000 TSA employees at 460 locations.

**Pincus, Jon** is co-chairing the Computers, Freedom, and Privacy 2010 conference in San Jose this June, and has helped organize a variety of social network activism projects including Get FISA Right, the Voter Suppression Wiki, Twitter Vote Report, and the #p2 ("progressives 2.0") Twitter hashtag. His current day job is co-founder and CTO of Qworky, a nascent Seattle-area startup focused on revolutionizing how people work together. Previous work includes a tumultuous 18-month stint as General Manager for Strategy Development in Microsoft's Online Services Group; creating the static analysis tools PREFIX and PREFast at his startup Intrinsic and then at Microsoft Research; and the National Academies/CSTB software dependability panel Sufficient Evidence?

**Pitts, Joe "Chip"** is President of the Bill of Rights Defense Committee. He is also an international attorney, investor/entrepreneur, and law educator who advises businesses on international, strategic, intellectual property, marketing, legal, and ethics matters. Formerly Chief Legal Officer of Nokia, Inc. and partner at a major global law firm, he currently serves on the board for Amnesty International USA and was the former board chair. He is a Lecturer in Law at Stanford University Law School and has taught at other law schools and universities.



**Polonetsky, Jules** has served since November 2008 as Co-chair and Director of the Future of Privacy Forum, a think tank seeking to improve the state of online privacy by advancing responsible data practices. His previous roles have included serving as Chief Privacy Officer at AOL and before that at DoubleClick, as Consumer Affairs Commissioner for New York City, as an elected New York State Legislator and as a congressional staffer, and as an attorney. He has served on the boards of groups such as TRUSTe, the IAPP, the Network Advertising Initiative, the Privacy Projects, and the Better Business Bureau (NY Region). **Rich, Jessica** is currently Deputy Director of the FTC's Bureau of Consumer Protection. Prior to that, Ms. Rich served for 11 years as Assistant and then Associate Director in the FTC's Division of Privacy and Identity Protection. In that position, she handled or oversaw a wide variety of privacy and data security matters, including: (1) enforcement actions against such companies as ChoicePoint, Microsoft, and TJX; (2) rulemakings to develop the FTC's Safeguards, Disposal, Children's Online Privacy, and Personal Health Records Rules; (3) testimony to Congress on proposed legislation and related issues; and (4) public workshops and policy initiatives, such as the FTC's "Exploring Privacy" Roundtables and Behavioral Advertising Project. Prior to joining the FTC's privacy division, Ms. Rich served as Counsel to the Bureau Director and was an attorney in private practice. She graduated from New York University Law School and Harvard College.

**Robinson-Van Gilder, Joy** is an Illinois children's privacy rights activist. When she learned in 2005 that a tiny school in Earlville, Il started to use biometric fingerprint capture technology children she was galvanized into action. She was told that the reason for adopting the technology was to speed up the lunch line at a school where the entire school district numbered fewer than 500 children. The rule was "Don't scan, Don't eat." He 7 year-old son) was scanned, without her consent and against Joy and her husband's objections. Her efforts lead to the Illinois Public Act 95-232, which prohibits the collection of biometric information on school age children without the parents' explicit consent. She was also instrumental in getting a similar measure passed in the state of Arizona. In June 2009, I was asked to speak on a panel at Northwestern Law in Chicago, Il.

**Rosenblum, Dr. Marc** is a Senior Policy Analyst at the Migration Policy Institute in Washington, DC and an Associate Professor of Political Science at the University of New Orleans. In 2006, Dr. Rosenblum was a Council on Foreign Relations Fellow detailed to the office of US Sen. Edward Kennedy during the Senate immigration debate, and he was involved in crafting the Senate's immigration legislation in 2006 and 2007, including provisions related to electronic verification, before serving as a member of President-Elect Obama's Immigration Policy Transition Team in 2009. His current work at MPI focuses on the US immigration policy debate, migration and US labor markets, and US-Mexican and US-regional migration issues. Dr. Rosenblum is the author of a 2004 book, *The Transnational Politics of US Immigration Policy*, and over 25 academic journal articles, book chapters, and policy briefs on immigration, immigration policy,

and US-Latin American relations. He is currently completing a book on the history of US immigration policy, and is the co-editor of the forthcoming Oxford University Press Handbook of International Migration.

**Rotenberg, Marc** is Executive Director of the Electronic Privacy Information Center (EPIC) in Washington, DC. He teaches information privacy law at Georgetown University Law Center and has testified before Congress on many issues, including access to information, encryption policy, consumer protection, computer security, and communications privacy. He testified before the 9-11 Commission on "Security and Liberty: Protecting Privacy, Preventing Terrorism." He has served on several national and international advisory panels, including the expert panels on Cryptography Policy and Computer Security for the OECD, the Legal Experts on Cyberspace Law for UNESCO, and the Countering Spam program of the ITU.
